



Helping Families Afford Valley School

2024-2025 School Year

We understand that a research-based, multisensory and personalized education requires a significant investment from families. Valley School families raise money for many activities throughout the school year. The money raised supports the afterschool sports program and various other activities that require funds which are outside the scope of the school's budget. A portion of the money raised is set aside for Tuition Assistance and to support families with multiple children enrolled at Valley School.

Tuition Assistance Applications are due by April 5, 2024. Late applications will NOT be accepted. Families will be notified by June 1, 2024 if they will be receiving Tuition Assistance.

Not all families who apply for Tuition Assistance can be awarded assistance. The final decision is made by the Valley School board and will be based on the financial aid budget, school's policies, applicants' supporting financial documents, and the needs of the family outlined in the application letter.

All families with multiple children enrolled at Valley School will be awarded a 10% tuition discount for each additional child enrolled. The discount applies to the additional child or children with the lower tuition amount. Families do not need to apply for this discount, it is automatically given. This discount cannot be combined with staff discounts.

Tuition Assistance Application

- Families must submit this application by April 5, 2024.
- Please submit only one application per family.
- The maximum assistance awarded is 20%.
- **Recipients of Tuition Assistance must be on the 10 payment plan for Valley School tuition.**
- Both parents must submit all required financial documents regardless if they are divorced, separated, or never married to be considered for Tuition Assistance.
- If the family or student receives any subsidy (such as CCRC) after the tuition assistance is granted, the tuition assistance may be reduced or forfeited as no discount can reduce tuition below the amount of the subsidy payment.
- At this time, the Valley School absorbs all the costs associated with processing these applications to support the families at Valley School. The Valley School board kindly asks that **ONLY** families that absolutely require help apply for assistance. Funding is limited and will be allocated to the families with the most need.
